## ADDENDUM

Whilst not forming part of any approval under Part III of the Air Navigation Order the following activities are approved in accordance with British Civil Airworthiness Requirements.

Control of flights under 'B' Conditions as defined in the Air Navigation Order;

1.1 For flights under 'B' Conditions, the following conditions shall apply unless specific written exemption is in force in any particular case.

1.2 For the purposes of this approval, the applicable CAA Requirements shall be as defined in BCAR A8-9. In addition,

1.2.1 The holder of this approval shall not allow an aeroplane to fly unless they have satisfied themselves that the aeroplane is in every way fit for the intended flight, in accordance with the procedures agreed by the Civil Aviation Authority and defined in the approved Company Exposition and any additional requirements which the Civil Aviation Authority may deem necessary in any particular case.

1.2.2 Aeroplanes not registered in the United Kingdom or under the law of any country referred to in Article 3 of the Air Navigation Order shall be marked in accordance with paragraph 9 of BCAR A8-9, the 'B' Conditions Number referenced there in being 52.

1.2.3 Flights over any congested area of a city, town or settlement shall only be undertaken in accordance with the control procedures defined in the approved Company Exposition.

1.3 By issue of this document, the Civil Aviation Authority hereby revokes any approval previously granted to Marshall of Cambridge Aerospace Limited or its predecessors, for the control of flights under 'B' Conditions.
